1. Purpose of the Gift

2. Form of the Gift

4. Investment, Management and Use

The Gift shall fully and immediately vest with the DI. Goods and services and or capital items purchased with funds received from this Gift will be used in accordance with the purpose of the Gift as described in Section 1 (Purpose of the Gift). Any residual funds from the Gift may be repurposed in accordance with Section 6 (Amendment). The DI has the authority to dispose of any capital items that no longer have a practical or economic value.

6. Amendment

This agreement may be amended with the mutual consent of the DI and the Donor during the lifetime of the Donor.

If changed circumstances should at some future time make it impractical to continue using all or part of the Gift for the purpose set out in Section 1 (Purpose of the Gift) of this agreement and the Donor is not living or not able to consent to an amendment to this agreement, then the DI may redesignate all or part of the Gift, provided that any such redesignation shall adhere as closely as is reasonably possible to the Donor's intent.

7. Entire Agreement

This agreement represents the entire agreement between the DI and the Donor with respect to the Gift and supersedes all prior discussions and negotiations relating to the Gift.
